## Logan Flora

Logan Flora is an assistant coach at St Norbert College. This pasted season he helped lead the Green Knights to a 20-8 record including winning the NACC conference championship, tournament title and a trip to the NCAA tournament. He helped with the development of 1st Team, NACC Defensive Player of the Year and NABC All-District 2nd team, Michael Payant. During the 2021-22 season he helped the Green Knights capture the NACC conference championship while helping with the development of NACC Freshman of the Year, Parker Lawrence.

Prior to his arrival he spent six seasons at Ripon College... In 2019-20 he helped the Redhawks finish with a 20-8 record which including winning the Midwest Conference Championship. He helped with the development of 2020 MWC Player of the Year and NABC All-District First Team, Trent Jones. During the 2016-17 season he helped with the development of NCAA 2nd Team All-American & 2017 Midwest Conference Player of the Year, Ty Sabin.

Flora spent three seasons as the Top Assistant coach and Recruiting Coordinator at the University of Mary. During his time at Mary he was able to recruit All-State student athletes from Colorado, Iowa, Minnesota, Illinois, Florida and Arizona.

Prior to that, he spent two seasons at the University of Minnesota-Duluth as an assistant coach.

Flora spent one season as the Head Coach at the University of Wisconsin-Superior, leading the Yellowjackets to the second most wins since 1978-79 and advanced to the WIAC conference tournament semifinals for only the 3rd time in school history

Flora spent the previous two seasons as the Director of Basketball Operations at NCAA Division I UW-Green Bay. During his time with the Phoenix, he helped with the development of the two-time Horizon League Defensive Player of the Year, six players that scored over 1,000 career points, the Horizon League Freshman of the Year, and six players that had professional careers overseas.

Flora came to Green Bay after serving as a graduate assistant coach at Northern State University, an NCAA Division II school in Aberdeen, S.D. coached by the all-time winningest coach in NCAA history, the legendary Don Meyer. He also has additional coaching experience which includes working at Appleton West, Appleton Xavier and Oshkosh North high schools.

## Brian Butch

Brian Butch is a two-time Wisconsin State Player of the Year by the Associated Press. Brian was Mr Basketball in 2003 as well. Brian averaged 22.8 points and 10.1 rebounds as a senior, leading Appleton West High School to a 23-3 record and the Division I State Championship game in 2003. He broke a 35-year old Wisconsin state tournament record by scoring 45 points in the quarterfinals. He is also Appleton West's All-time leading scorer with 1,431 points. Brian was later named a 2003 McDonalds All-American.

Brian's collegiate career at the University of Wisconsin began as a freshman, Brian played in 27 games. Butch was named academic All-Big Ten, and helped the Badgers reach the Elite Eight. As a sophomore, Brian played in 31 games, averaging 9.9 points, 6.0 rebounds. He scored a career-high 23 points and grabbed career high 12 rebounds vs. Penn State. In his junior year, he played in 30 games before severely dislocating his elbow. The Big Ten conference's coaches selected Butch as All-Big Ten Honorable Mention. In his senior year, the Badgers posted the most wins in school history with a 31-5 record. Playing in 36 games, Brian's stats include: 12.4 ppg, 6.6 rpg en route to Big Ten Regular Season and Tournament Championships and earning a to trip to the NCAA Sweet Sixteen. The Big Ten conference's coaches named Butch First Team 2007-08 All-Big Ten Basketball Team, as-well-as Big Ten Sportsmanship Award Honoree.

Brian's professional career began with a stints in Spain, China, and Germany as well as the Greek league team Illisiakos. Next Brian signed with the Bakersfield Jam of the D-League. As the Jam's starting center, he was awarded a spot on the D-League Western Conference All-Star team. He was named the All-Star Game's Most Valuable Player. Brian signed with the Denver Nuggets on April 4th, 2010. He suffered a server knee injury that summer and rehabbed for a full 15 months. Brian represented his country and played for Team USA in the Pan-American games in 2011. After the NBA lockout Brian attended training camp with the New Orleans Hornets. Due to an injury he was released. He returned to the Bakersfield Jam and the NBA D-league, Brian was traded to the Ft Wayne Mad Ants to finish out the year. Brian finished up his career with stops in Dubai & Japan for 2 years.

Brian was an assistant coach for the Milwaukee Bucks G-League team the Wisconsin Herd for two years. Brian hosts a Statewide radio show called Nine to Noon on Iheart Radio with former Packer John Kuhn. Brian is also an analyst and studio host for the Big Ten Netwok & Fox Sports.
